## 7. Items not on the Agenda

**Ākitio Remediation:** A verbal update was provided by the Three Waters Manager who outlined that the pipeline from the treatment plant to the top tanks required replacement, due to the material it had been constructed with not being appropriate. This was causing a number of leaks to develop. He spoke about where this work fitted in with the priority of other required works in the District, and noted that the work would likely take closer to Christmas, when demand would increase.

In response to a question regarding the intention to encourage Ākitio residents to adhere to the Water Supply Bylaw requirements, it was noted that the Council's regulatory compliance team would be working on ensuring compliance requirements for users not just in Ākitio, but also Pongaroa and Norsewood.

#### 10.1 Infrastructure Management Report

#### 10.4 Capital Portfolio Report

The Infrastructure, Climate Change and Emergency Management Committee considered the report of the Manager - Programmes & Projects dated 04 April 2024 that provided an update on the capital programme and key project statuses. In regards to the impounded supply, it was stated that an impact classification and risk assessment would need to be carried out before further reports could be

provided.

Additionally, in discussion it was asked whether a definitive response regarding the reassessment of the Bill of Rights had been returned by the Ministry of Health; it was confirmed that no response had as yet been received, and that the direction was to continue for now - noting the plant did not need to be active until September. It was queried whether, given the high level of public interest, any extra security would be required on the construction site of the fluoridation plant. It was responded that this was uncertain at present.
