#### 8.1 Infrastructure Management Report

The Infrastructure, Climate Change and Emergency Management Committee considered the report of the Group Manager - Infrastructure dated 8th May 2024 that provided an update on key activities and items of interest over the period 12 March to 11 April 2024.

The committee discussed concerns regarding the unsuitability of the detour put in place by Waka Kotahi, during the recent closure of SH2 to allow works to be done on the Tamaki River bridge. In response to a question on the level of prior engagement undertaken by Waka Kotahi with Council's transport team and the assessments undertaken of the detour route, it was noted that the detour route was established through an internal process at Waka Kotahi and the communication of the arrangement with Council beforehand needed improvement. It was noted that a faults inspection was undertaken prior to the opening of the detour, and following its closure.

## 10. Items not on the Agenda

- 10.1 **Progress with wastewater pipe remediation on Allardice Street**: an update was provided on the additional work required for the works, that has seen the works take a longer length of time than originally estimated.
- 10.2 Attendance at Road Control and Authority Seminar: an update was provided on the attendance by Her Worship the Mayor, Cr K Sutherland, and the Group Manager – Infrastructure at the Road Controlling Authorities Forum seminar held in Wellington. The Chairperson noted that Ministers Simeon Brown, Shane Jones and the Chief Executive of Waka Kotahi were among the attendees. The discussions included the funding of infrastructure projects, highlighting the need for reduction in costs. Her Worship the Mayor outlined the Panel discussion that took place, which included matters such as the need to fund road and rail from one system, noted that 90% of assets were owned by local government, the costs of traffic management, and the need to take a long term view, possibly through a bipartisan 50 year infrastructure strategy. The discussion also included finding a different approach to funding. The Group Manager – Infrastructure spoke about the message provided for Councils to find efficiencies, to spread the funding provided further, and to get through the planning stages faster to speed up delivery.

There being no further business the Chairperson thanked those present for their attendance and contributions, and declared the meeting closed at 2:53pm.
