A forum will be held to consider the option of a Maori Ward for the 2022 election as part of this year's representation review.

Both of Council's iwi partners Rangitāne o Tamaki Nui-a-Rua and Ngāti Kahungunu ki Tāmaki nui-a-Rua have requested this option be implemented.

If the Council is to propose a Maori Ward for the 2022 election it must do so by 21 May 2021, otherwise that option cannot be applied until the 2025 election.

Any decision to form a Maori Ward is then considered through a representation review that is subject to public consultation to determine the basis of the electoral arrangements for the Council.
