## **13. Super Consultation Round 2**

13.1 Council appointed Board Member Cr Erana Peeti-Webber abstained from discussion to agree the Board's submissions and feedback in response to Council's Super Consultation Round 2 document.

13.2 The Board considered and noted each topic discussed with the community in the Super Consultation Round 2 document, and supported to convey its specific comments to Council regarding the following matters:

### **Water Supply Bylaw**

Access to the water supply in rural areas where that service is available but the property is not connected presently incurs a half charge through the rates system.

The proposed approach to discontinue applying that rating charge where a rural property is not receiving this service is supported, particularly if it has made alternative storage arrangements for its water supply.

As an incentive to support and encourage the installation of water tanks for storage and emergency use the Board support Council facilitating assistance for that purpose.

This should be provided through Council's buying power to bulk purchase tanks, and making them available to residents on a cost recovery basis where they have the option of paying the purchase price through their rates instalments.

Minimum tank sizes required to supply adequate capacity as outlined in the draft bylaw are supported, being 5,000 litres in urban areas and 30,000 litres outside an urban supply area for the development of new sections of 1,000 square metres and above.

### **Annual Plan 2022/2023**

The impact of the proposed 11.37% rates increase on people with low and fixed incomes and pensioners at a time when the cost of living and inflation is rising is of concern with regard to affordability.

To help alleviate this situation Council is urged to lobby central government and advocate to review the level of the rates rebate thresholds to provide increased assistance to those eligible for that support, thereby recognising the rising cost of rates in addition to prices escalating for other essential everyday items.


There being no further business the Chairperson thanked those present for their attendance and contributions, and declared the meeting closed at 2.30pm.
